

ATHLETES RELEASE AND WAIVER OF LIABILITY ASSUMPTION OF RISK, INDEMNITY - NAME AND LIKENESS RELEASE

IN CONSIDERATION OF (a) being permitted to compete, officiate, observe, work for, or participate in any way in the Gatorade Free Flow Tour (hereafter referred to as Event(s) or (b) being permitted to enter for any purpose any Restricted Area (defined as any restricted area requiring special authorization, credentials, or permission to enter any area where admission by general public is restricted or prohibited), including but not limited to, the competition area and the athlete lounge areas. EACH OF THE UNDERSIGNED, for himself/herself, his/her personal representatives, parent or legal guardian, heirs, and next of kin:

1. Acknowledges, agrees, and represents that he/she has or will immediately upon entering any of such Restricted Areas, and will continuously thereafter, inspect the Restricted Areas which he/she enters and he/she further agrees and warrants that, if at any time, he/she is in or about Restricted Areas and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the Restricted Areas and/or refuse to participate further in the Event(s).
2. HEREBY Releases, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE, Alli, Alliance of Action Sports, LLC, and its affiliate agencies and partners including The Gatorade Company, a subsidiary of PepsiCo Inc, NBC Universal, Inc., NBC Sports Ventures, Inc., Fuse, LLC, MTV Networks, their respective representatives, officers and employees, and those in privity with them including without limitation any co-promoters, participants, sanctioning organizations or any subdivision thereof, including any parents or affiliated entities, rescue personnel, medical personnel, any persons in any Restricted Areas, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the Event(s), premises and event inspectors, surveyors, underwriters, consultants and others who provide recommendations, directions, or instructions or engage in risk evaluation or loss control activates regarding the premises or Event (s) and each of them, their directors, officers, agents and employees all for the purposes herein referred to as "Releasees" FROM ALL LIABILITY TO THE UNDERSIGNED, his/her personal representative, parent or legal guardian, assigns, heir, and the next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY, OR RESULTING IN DEATH, TO THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT (S). WHETHER CAUSED IN WHOLE OR IN PART BY THE SOLE OR CONCURRENT NEGLIGENCE OR WRONGDOING, STRICT LIABILITY OR FAULT OF THE RELEASEES OR OTHERWISE.
3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE OR COST they may incur arising out of or related to the Event (s) WHETHER CAUSED BY THE SOLE OR CONCURRENT NEGLIGENCE, STRICT LIABILITY, OR FAULT OF THE RELEASEES OR OTHERWISE.
4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the Event(s) WHETHER CAUSED BY THE SOLE OR CONCURRENT NEGLIGENCE OF RELEASEES OR OTHERWISE.
5. HEREBY acknowledges, that THE ACTIVITIES OF THE EVENT (S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges the INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES. The UNDERSIGNED authorize and provide full consent to Alli, Alliance of Action Sports, LLC, and its affiliate agencies and partners including, The Gatorade Company, a subsidiary of PepsiCo Inc, NBC Sports Ventures, Inc Fuse, LLC, MTV Networks, its subsidiaries, affiliates, agents, contractors, vendors, volunteers or others, subject to the release, waivers and indemnities contained herein, to see and/or provide medical attention/treatment, including the release and distribution of medical records the respective entities may deem necessary and appropriate in the event the undersigned is unable, unfit or not qualified to make such decisions.
6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk, Indemnity and Rights Agreement extends to all acts of negligence or wrongdoing by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS, and is intended to be as broad and inclusive as is permitted by the laws of the Province or State in which the Event(s) is/are conducted and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
7. Agrees that he/she will not record, film, or videotape his/her performances in the Events except for personal, non-commercial uses only; and further agrees that any such recordings, photograph, film or footage shall not be used, given away or otherwise distributed in any manner, whether individually or through any license of other authorization to any third parties, for any purposes (other than for personal, non-commercial uses), including without limitation: COMMERCIAL SALE, PROFITS (DIRECT OF INDIRECT), REPRODUCTION, BROADCAST, PUBLIC DISPLAY, PROMOTIONAL OR MARKETING PURPOSES, ETC.
8. HEREBY agrees that he/she is in good health and has no physical conditions that affect his/her ability to compete in the Event(s) and has not been advised otherwise by a medical practitioner. He/she is covered by medical insurance, individually or as part of an organization.
9. HEREBY agrees to wear appropriate safety equipment, as established by industry standards and common safety practices, during all activities and competitions at the Event(s) and agrees to assume all risks associated with a failure to wear appropriate safety equipment.
10. Has read and understands all official documents, rulebooks, competition guidelines and agrees to the rules and regulations and code of conduct as outlined in those documents, and understands that failure to comply may result in the forfeiting of prize money and/or suspension from Event(s).
11. Grants to Alli, Alliance of Action Sports, LLC ("Alli"), NBC Universal, Inc., NBC Sports Ventures, Inc., Sports Ventures Sub, Inc., MTV Networks, a division of Viacom International Inc., and its affiliates, their licensees, sublicensees and assigns ("Property Owners"), in perpetuity and throughout the world, and without further compensation or consideration, the right and license to take video and still images of me, and to use and reuse, adapt, change, edit, modify, add to, delete, combine with other materials, record, reproduce, distribute and otherwise exploit my recorded performance, name, voice and likeness and biographical information about me in all forms of media (electronic or otherwise) now existing or hereafter created in perpetuity, including without limitation all forms of television (standard and non-standard television and home video distribution), video, photography and the internet in connection with: (a) the Events, telecasts of the Events and Alli; (b) publicity, advertising, promotions and promotional materials for the Events, telecasts of the Events and Alli; and (c) in future Events produced or sanctioned by Alli, and telecasts and promotions of those Events and Alli.
